TORONTO, Ontario (May 10th, 2007) — GlobeStar Mining Corp. announced today that its Board of Directors has appointed Stuart F. Feiner as a director. Mr. Feiner, who currently serves as a consultant to certain organizations, spent thirty years with Inco Limited, a leading international metals and mining company that was recently acquired by CVRD.
